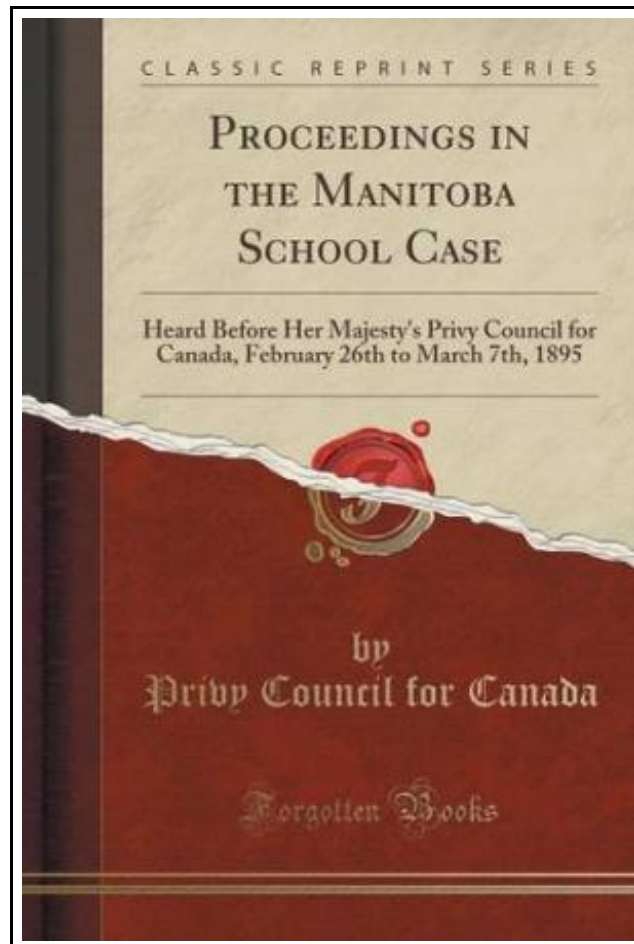

If it is a reasonably short postponement for the purpose of preparation, I will not object. Sir Mackenzie Bowell. - I was going to ask you, Mr. McCarthy, what time would you require to prepare your argument? Mr. McCarthy. - It is not so much for myself I am speaking as for the Attorney General; and what I rather gathered from him, though he has not said so in words, was that he desired to have been here himself. It is a matter which involves the educational system of the province, a question which, of course, has attracted a great deal of attention in Manitoba, and has been a subject of discussion in more than one session. I think what he would like is such a postponement as would enable him to go on with the work of the session and to come here after the session. You are aware, of course, that Mr. Greenway, the First Minister, is ill, and the leadership of the House, I suppose, devolves upon Mr. Sifton, the Attorney General. He instructed me that he telegraphed to this effect on Saturday, to the Secretary of State. Mr. Ewart. - I would object most strenuously to any postponement over the present session of the legislature. You are aware that there has already been very great delay in reaching a solution of this case, and...
